The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 5,677.8 million square meter equivalents (MSME) in October 2016, an increase of 1.4 percent compared to October 2015. Imports of textiles were 3,205.3 MSME in October 2016, up 2.4 percent from October 2015. Imports of apparel were 2,472.5 MSME in October 2016, remaining flat from October 2015.

Imports of textiles and apparel were 52,956.4 MSME for the year-to-date October 2016, a decline of 2.0 percent from year-to-date October 2015. Imports of textiles were 30,065.5 MSME for the year-to-date October 2016, a decline of 2.4 percent from the year-to-date October 2015. Apparel imports for the year-to-date October 2016 were 22,890.9 MSME, down 1.4 percent from the year-to-date October 2015.
